<u>CONSOL ENERGY APPEAL</u> - Chris Kessler, Assessor, stated Consol Energy is appealing a value established with the Bailey Mine – Dry Ridge Portal, in Webster District. Craig Griffith with Steptoe & Johnson appeared representing Consol Energy and Jan P. Mudrinich, Esq. appeared representing the WV State Tax Department. Mr. Griffith stated Consol Energy filed an amended return which the State Tax Department has reviewed. An agreement has been made between Consol Energy and the State Tax Department with a revised assessed value reduction of \$16,771,149.

Hunter and his wife appeared before the Board concerning their mineral account, #09-9999-0001-0347-0000, the Hunter-Pethtel 1H well, with an appraised value of \$ 392,476 and an assessed value of \$235,490. Mr. Hunter had questions about his mineral appraisal. Chris Kessler, Assessor, Yvonne Estep, WV State Tax Audit Clerk Sr., and Cindi Hoover, WV State Tax & Revenue Manager answered questions and explained definitions of Class 2, Class 3, and the formula that is set by the State of West Virginia.

After a discussion, on motion of Commissioner Stewart, seconded by Commissioner Varner, the Board approved and accepted the appraised value of \$392,476 and assessed value of \$235,490 established for the 2015 property books. Motion carried.
