2016 PRIMARY ELECTION INFORMATION – Jan Pest, County Clerk, appeared before the Commission. Jan stated the West Virginia Statewide National Convention-At-Large Delegate race has 220 candidates, which is more than the declared system limits currently support. Therefore, Election Systems & Software has developed and tested, with consultation from SOS and EAC, an enhanced version of software which will increase the current candidate limitation number. Each jurisdiction will be required to install the enhanced update to ERM and an updated version of the EXP Utility onto our Reporting PC's.
